WHEREAS, the YMCA utilizes some of the Montclair Board of Education's schools for the purpose of

providing before and after care services, and

WHEREAS, it is in the best interest of the taxpayers of the Township of Montclair to allow use of these

facilities on a rent-free basis,

BE IT RESOLVED that the Montclair Board of Education does hereby approve the use of facilities with the

YMCA on a rent-free basis as described above, and

SHARED SERVICES AGREEMENT WITH MONTCLAIR TOWNSHIP TO PROVIDE FOR SCHOOL RESOURCE OFFICERS FOR THE 2021-2022 SCHOOL YEAR

whereas, the Uniform Shared Services and Consolidation Act, N.J.S.A. 40A:65-l, et seq., (the "Act") permits units of local government to share services for particular purposes and to effectuate agreements for any service or circumstance that will aid and encourage a reduction of local expenses; and

where are police officers specifically trained in educating, counseling, and protecting the public in an educational setting within the Township of Montclair Police Department known as School Resource Officers (SROs); and

WHEREAS, the Township of Montclair ("Township") and the Montclair Board of Education ("MBOE") are partners in providing for School Resource Officers (SROs), and acknowledge that these officers have been a constructive and valuable presence in the schools; and

WHEREAS, the Township of Montclair and the Montclair Board of Education are public bodies corporate and politic of the State of New Jersey and are authorized under New Jersey Law to enter into a Shared Services Agreement pursuant to the Act.

BE IT RESOLVED that upon the recommendation of the Superintendent, the Board of Education approves as follows:

- 1. The Board is hereby authorized to execute a Shared Services Agreement, in substantially the form attached hereto;
- 2. The Shared Service Agreement shall take effect upon the adoption of this resolution and execution of the Agreement by both parties;
- 3. A copy of the executed Shared Services Agreement shall be filed, for informational purposes, with the Division of Local Government Services in the Department of Community Affairs.
