CONTRACT FOR PROFESSIONAL SERVICES FOR EMERGENCY MANAGEMENT AND SCHOOL SAFETY/SECURITY CONSULTANT

- **WHEREAS,** in accordance with <u>N.J.S.A.</u> 18A:18A-4.5, the Board advertised for Request for Proposals for Emergency Management and School Safety/Security Consultant; and
- WHEREAS, on December 17, 2021, the Board received proposals; and
- WHEREAS, upon review of the proposals, it has been determined that StoneGate Associates, LLC is the firm who has both the qualifications necessary to perform the services along with the acceptable rate required to best serve the district;
