REVISED DELEGATION OF DISTRICT PURCHASING AGENT

WHEREAS, N.J.S.A. 18A:18A-2.b. states that the purchasing agent means the secretary, business administrator or the business manager of the board of education duly assigned the authority, responsibility and accountability for the purchasing activity of the board of education and having the power to prepare advertisements, to advertise for and receive bids and to award contracts as permitted by this chapter,

WHEREAS, N.J.S.A. 18A:18A-2.b. further states that but if there be no secretary, business administrator or business manager, such officer, committees or employees to whom such power has been delegated by the board of education.

NOW THEREFORE, BE IT RESOLVED, the Montclair Board of Education, pursuant to N.J.S.A. 18A:18A-3 (a), designates Jonathan C.
